PROGRAM SPEAKERS ARE TRANSPLANT RECIPIENTS OR HAVE A CONNECTION TO A TRANSPLANT STORY. THESE PRESENTATIONS ARE PROVIDED FREE OF CHARGE, AND INFORM STUDENTS ABOUT THE LIFE-SAVING IMPORTANCE OF ORGAN, EYE AND TISSUE DONATION, AND EMPOWER THEM TO HAVE A CONVERSATION WITH A LOVED ONE ABOUT THEIR DECISION. BECAUSE OF THESE POWERFUL PRESENTATIONS, 45% OF STUDENTS FOLLOW THROUGH WITH A FAMILY DISCUSSION. MORE INDIVIDUALS JOIN THE STATE DONOR REGISTRY IN COUNTIES WITH SCHOOLS THAT HAVE CONSISTENTLY PARTICIPATED IN THE LIFE SAVERS PROGRAM THAN IN THOSE THAT HAVE NOT.
